# **Good Morning**

#### INTRODUCTION

- 1. It is a great pleasure and honour to be here for such a happy occasion where we handover tablets to St. Catherine High School and Mt. Royal High School respectively.
- 2. The Bank's support to the above-mentioned schools is implemented in terms of the powers conferred upon the Board of Directors under Section 8 of the Central Bank of Lesotho Act No.2 of 2000.
- 3. To deliver on this task, the Bank has the Corporate Social Responsibility (CSR) Policy, which serves as a guiding framework through which it may extend a helping hand by means of donations and sponsorships to various qualifying social groups and communities in line with the five priority areas under this Policy.

- 7. It is hoped that our intervention at St. Catherine and Mt. Royal with 20 tablets per school will enable both the deaf and blind children to better taste some of the privileges that are being enjoyed by their peers who do not have any special needs such as the effective usage of technology.
- 8. This means, the Bank has decided to help these schools based on its firm believe that it is very important for all children to have the same access to education. Through that, children with disability will be able to decide what they will do in the modern world of technology amongst others.
- 9. The role of educational institutions like these schools is critical and we feel that it is also our responsibility to continuously support children with disability, thus contributing towards the achieving of the country's financial inclusion agenda.

# Ladies and Gentlemen,

- 10. Every year the Bank receives a number of requests from all directions requesting support. The requests are evaluated by a team of experts and a decision is made on which requests are supported. As you can imagine, the amount allocated is small and the Bank makes all in its power to see that most of the projects get support.
- 11. It is therefore, my fervent hope that these tablets will serve the purpose they are intended for, which is the direct benefit to children with disability.
